Critical Race Theory: Why it's Banned and Why it Matters

Course Description

In this class, we will break down the controversies surrounding Critical Race Theory. We begin by defining the many terms that have moved out of scholarly circles and into the headlines: including critical race theory, structural racism, white supremacy, white privilege, antiblackness, settler colonialism, racial hierarchy, and Islamophobia. We then dig more deeply into the research and evidence for structural racism, examining case studies on the criminal justice system, drug policies, mass incarceration, police violence, health, education, the environment, housing, the economy, the job market, and voter suppression. Lectures and readings will focus on racial inequality and its impact on African Americans, Latinx peoples, Asian Americans, Indigenous people, and Arab Americans in the US context, but international examples will be discussed as well. This class will be especially useful for anyone who wants to be exposed to an engaging and interactive synthesis of the last few decades of academic scholarship and hopes to equip themselves with relevant data and theoretical concepts.

This course assumes no prior knowledge in critical race studies, and there will be time dedicated each class to addressing participants' specific interests and questions. Based on the professor's training and experience, the class will offer an anthropological lens to approaching current day racial ideas and experiences of inequality, while pointing out important historical connections. Supplemental recommendations for readings to go deeper into any of the course topics will also be provided. Participants from a wide range of backgrounds are welcome, and educators who would like more solid grounding in these issues to better support their students are especially encouraged to participate.

Faculty Bio

Jen Roth-Gordon is Associate Professor of Anthropology at the University of Arizona where she has taught racial and social justice classes to thousands of undergraduate and graduate students since 2004. Her first book, *Race and the Brazilian Body: Blackness, Whiteness, and Everyday Language in Rio de Janeiro*, interrogates racial inequality and common beliefs in the superiority of whiteness and has been taught in university classes around the country. She is currently working on two new research projects, one on middle-class parenting and connections between the defense of whiteness and racial violence and the other on extreme heat and experiences of structural racism in Rio.
