LIVING DEMOCRACY

In this seminar we will explore how democratic ways of living can help us sustain democracy through dark times. Our country has been characterized as a "faltering" democracy for more than a decade by <u>international monitoring groups</u>. Commentators have focused on the rise of authoritarian populism around the world and the widespread <u>dehumanization of daily life and degradation of civility</u>. This syllabus was drafted two weeks before the Biden-Trump debate and will be revised after the election.

In our class discussions, we will downshift from these global trends to examine the democratic arts of listening, reasoning, and imagining together as a way to sustain hope and resist demagoguery. We will explore how such equitable ways of thinking and living can help us stand against factionalism, injustice, and post-factual politics. We will take note of national deliberations on the economy, immigration, and environmental and social


change, but our central focus will be on how thinking globally and engaging locally to live democratically can help us resist tyranny, support those in need, and develop a more grounded understanding of the issues and opportunities we face.

While the topics of our discussion will be changed by the historic election we are living through, I am currently envisioning six classes that should be relevant whichever party is in power:

- 1) The Ends of Democracy: We will step back from the deadening din of debates on how our democracy may be coming to an end to renew our sense of the ends we hope our democracy can achieve. In the course of our discussions, we will remind ourselves of the resilience of democratic ways of living to help us reflect on the waves of migration, activism, and social and technological changes that we have lived through and younger Americans were born into.
- **2) Conflicted Visions/Shared Problems**: We will examine how the issues and movements that proved decisive in the fall election were shaped by competing visions of American democracy. We will focus on what minority, women, younger, and other swing voters imagined they were voting for and against.
- 3) But What Can We Really Do? It can be hard not to slip into despair when we watch elections go badly and judicial and legislative decisions roll back human rights and environmental protections. To counteract this debilitating fatalism, we will explore how women, African Americans, and others have organized to defend their rights against hostile regimes and oppressive social hierarchies.
- 4) Keeping the Democratic Imagination Alive in Deadening Times: After our discussions of the visions of democracy set out in the election and by the new administration, we will examine texts such as Langston Hughes' "Let America Be America Again" to consider how artists from marginalized groups have envisioned the potentials of our

democracy to sustain hope in dark times.

- **5) #StruggleContinues:** We will explore how social movements are being networked in ways that are transforming the lives of younger generations. We will examine #BLM and other hashtag movements that mobilize local groups within national and global networks. We will also consider how such networks are changing how younger people think and connect with others.
- 6) Caring Democracy: The ills that have infected our democratic life are often defined in moralistic and nationalistic terms that can reduce democracy to a form of political governance in a way that divorces how we live from how they govern. A healthier and more purposeful democratic life emerges when we consider caring for ourselves and others as a part of grassroots collective action.


